- 2. REF A ESTABLISHES COMMANDER NRSW POLICY FOR LEAVE AND LIBERTY FOR THE MEXICO BORDER REGION FOR ALL NAVY PERSONNEL. REF B ENCLOSURE 11. REQUIRES ALL CNAF COMMANDS TO ESTABLISH AN INDIVIDUAL ANTITERRORISM PLAN (IATP)/TRAVEL TRACKER ACCOUNT WITH COMPACFLT AT HTTPS://PACCAS.NMCI.NAVY.MIL/NAVY/CPF/ATFP/HOME.NSF.
- 3. CNAF, CNRSW AND COMPACFLT HAVE COORDINATED TO ADD TO THE (IATP)/TRAVEL TRACKER PROGRAM REQUIRED MEXICO BORDER REGION REFERENCE MATERIALS.
- 4. POLICY: ALL CNAF PERSONNEL VISITING MEXICO ON LEAVE OR LIBERTY SHALL EMPLOY THE COMPACFLT TRAVEL TRACKER PRIOR TO TRAVEL TO DOCUMENT LEAVE AND LIBERTY ITINERARY / PLANS. LIBERTY INCLUDES ALL TRAVEL ACROSS THE BORDER, REGARDLESS OF TIME PLANNED IN MEXICO. TRAVELERS SHALL CAREFULLY REVIEW LINKED REFERENCE MATERIALS AS AN AUGMENT COMMAND COUNSELING REQUIRED BY REF A. DISCIPLINED TRAVEL TRACKER USE WILL ALERT COMMAND IATP COORDINATORS AND SUPERVISORS TO LEAVE AND LIBERTY PLANS OF THEIR PERSONNEL. TRAVEL TRACKER PROVIDES THE ADDITIONAL BENEFIT OF ALLOWING COMMANDERS TO INSTANTLY ACCOUNT ALL PERSONNEL ON TRAVEL AT ANY TIME.
- 5. FOR PERSONNEL WITH SECURITY CLEARANCES TRAVEL TRACKER USE FACILITATES COMPLIANCE WITH GUIDELINES SPECIFIED FOR TRAVEL TO FOREIGN COUNTRIES ESTABLISHED IN REF C, PARA 3-7 AND PARA 4-10. (QUOTE) IT IS IN THE BEST INTEREST OF THE COMMAND AND THE TRAVELER TO ENSURE TRAVELERS ARE FULLY PREPARED FOR ANY PARTICULAR SECURITY OR SAFETY CONCERNS THAT THE FOREIGN TRAVEL MAY INTRODUCE. (UNQUOTE)
- 6. THE COMACFLT IATP/TRAVEL TRACKER PROGRAM IS A PROVEN METHOD TO ASSURE PERSONNEL ASSIGNED TO CNAF COMMANDS MEET ALL ADMINISTRATIVE TRAVEL REQUIREMENTS, PROPERLY ASSESS RISKS BASED ON THE CURRENT THREAT SITUATION, PREPARE INTELLIGENTLY TO MITIGATE THOSE RISKS. ADDING MEXICO LIBERTY AND LEAVE TO THIS TOOL WILL ASSURE ALL PERSONNEL CAN BE RAPIDLY CONTACTED IN RESPONSE TO CHANGING CONDITIONS. PROPER USE OF THIS TOOL, COUPLED WITH EFFECTIVE LEADERSHIP FROM THE WARDROOM AND CHIEFS MESS, WILL BETTER PREPARE OUR SAILORS FOR LEAVE OR LIBERTY IN MEXICO. //
